If you are looking for a unique experience, in your career, enlist your participation in **Certified Examiner for Performance Excellence (Formerly known as Certified Examiner for Quality Management) program conducted by the IMC Ramkrishna Bajaj National Quality Award Trust (IMC RBNQA)**. Every year the IMC RBNQA process seeks a Board of Examiners capable of evaluating organization participating in the prestigious awards.

Since 1996, the IMC RBNQA Trust has been working with Indian organizations in mapping their excellence journey. An endeavors towards national-building.

*The purposes of the Award are to: a) promote awareness of Performance Excellence and best practices in Indian Organizations; b) recognize achievements of Indian organizations in the Excellence journey; and c) publicize successful quality strategies and programs.*

The institution of this National Quality Award is a nation-building activity in which we will need the support of senior leaders like you. We seek your help in the form of nominations of **Senior Managers & above/Academicians/Health Care Professionals from your esteemed organization to the Board of Examiners for the 2024 cycle. An individual can also do self-nomination.** The Board of Examiners for assessing the applications for the Award plays a very important role in the administration process.

The candidates for the Board of Examiners should be individuals from different functions, preferably with experience of more than one department, some interest and involvement in TQM initiatives and a general grasp of the business.

The **benefits to the organization** nominating their representatives to the Board of Examiners are:

- Availability of trained in-house expertise to facilitate self-assessment in the organization along the lines of the IMC Ramkrishna Bajaj National Quality Award Criteria for Performance Excellence.
- Availability of a trained expert to prepare an application as and when the organization decides to apply for the IMC Ramkrishna Bajaj National Quality Award.
- Membership to an exclusive fraternity of Examiners
- Network with some of the nation's foremost experts in business, education, and health care
- Learn how leading organizations achieve performance excellence
- Develop analytical and consensus-building skills and a systems perspective that can be applied at your home organizations.

The **time commitment** required of the representatives nominated by your organization would be:

1. To undergo **four days of training** to qualify as a **Certified Examiner for Performance Excellence** (formerly known as *Certified Examiner for Quality Management*) at virtual platform.
2. Post qualification if the candidate **receives an application for assessment**:
  - About 50 man-hours of professional input at their own convenience in September/October, 2024 for independent review and evaluation.
  - Two days of Consensus Review (Virtual Platform) with other members of the Team of examiners in October/November, 2024.
  - Two to three days for site visits (actual site) in November/December/mid-January; 2024. This will be applicable only if the application assigned to the team qualifies for a site visit.

Only those **candidates who pass the examination** to be held on the fourth day will qualify to the Board of Examiners and **receive a certificate.**

**On being selected to receive an application and completing the entire evaluation process, the Examiners would be paid an honorarium for the professional services rendered by them to IMC RBNQA.**

We, therefore, request you to kindly nominate the representatives from your organization to participate in the 4-day Training Program.
